22. If the tenderer fails to complete the supply/complete the work within the period prescribed, the Managing Director, Kolhapur Zilla Sahakari Dudh Utpadak Sangh Ltd., shall be entitled, at his option, to recover from the tenderer, as penalty a sum equivalent to half percent of the total cost for delay of each week or part thereof during which supply is delayed, subject to the maximum of 3% of the tendered cost of the contract.
23. The tenderer shall arrange for insurance etc. of his people employed for erection and installation work as per ESIS ACT, WORKMEN COMPENSATION ACT, and any other provision to meet statutory requirements of various Labour Acts/Rules. In case of accident to any of his person in his employment or agents during the period of installation, the office of the Kolhapur Zilla Sahakari Dudh Utpadak Sangh Ltd. shall not bear any liability whatsoever. The entire responsibility primary and final in this respect will be that of tenderer.

24. The responsibility for completing the contract and commissioning the Analyzer units rests with the tenderer.
25. It shall be the responsibility of the successful tenderer to have comprehensively insured the goods against any risk i.e. against the damages that may be caused during the stage of transition, execution, trials, fire, theft etc. till final handing over of the entire equipment to Kolhapur Zilla Sahakari Dudh Utpadak Sangh Ltd. after satisfactory trials.
26. Contacting the purchaser (Kolhapur Zilla Sahakari Dudh Utpadak Sangh Ltd.): -
From the time of tender opening to the time of contract award, if any tenderer wishes to contact Kolhapur Zilla Sahakari Dudh Utpadak Sangh Ltd. on any matter related to the tender, it should do so in writing. Annexure - I

Technical Specifications – Electronic milk analyzer with adulteration testing facility

Functional Requirement:

- 1) Product to be analyzed: Raw milk
- 2) Raw Milk Quality and Adulteration testing Analyzer should be based on the proven FTIR based technology for milk composition analysis as well as for adulteration testing.
- 3) Equipment should be able to give accurate measurement of FAT, SNF and Protein with good repeatability.
- 4) The equipment should be supplied with all the required calibrations with provision to upgrade / modify from time to time, if needed.
- 5) The equipment should be able to screen and display minimum 12 adulterants at least as per below mentioned adulterant list (a to e are mandatory):

Principal Adulterants:

- a) Urea – LOD of 0.1% or lower
 - b) Ammonium sulphate – LOD of 0.1 % or lower
 - c) Maltodextrin – LOD of 0.6% or lower
 - d) Sucrose – LOD of 0.6% or lower
 - e) Added Water – LOD of 20% or lower
- Other Adulterants : (minimum 7 from below mentioned adulterants)
- f) Glucose
 - g) Sorbitol
 - h) Melamine
 - i) Sodium Chloride
 - j) Sodium Citrate
 - k) Starch
 - l) Hydrogen Peroxide
 - m) Formalin
 - n) Detergents
 - o) Sodium Carbonate
 - p) Sodium Bicarbonate
 - q) Vegetable oils with chemical emulsifiers
 - r) Sodium Hydroxide
 - s) Any other chemical with IR absorbance

Equipment should compare the spectrum of the sample with the spectrum of pure milk by using suitable statistical techniques and software to detect abnormality.

The equipment should be capable to screen adulteration by Urea, Sucrose, maltodextrin, glucose, sorbitol etc., which enhance the SNF part of Milk. Also, if these adulterants are added within limits of detection (LOD), then machine should not record higher value of SNF attributed due to added adulterants within limit of detection.

- 6) Equipment should be able to analyze Fat, SNF & Protein in the range of
 - a) Fat : 0.5-12%
 - b) Protein : 2-6%
 - c) SNF : 6-12%

The above ranges are the minimum required criteria, equipment with wider working range on both sides would be acceptable.

- 7) Accuracy in SD of milk parameters for compositional analysis should be minimum as below:
 - a) Fat ≤ 0.10
 - b) Protein ≤ 0.10
 - c) SNF ≤ 0.15
- 8) Repeatability in SD of milk parameters for compositional analysis should be minimum as below:
 - a) Fat ≤ 0.05
 - b) Protein ≤ 0.05
 - c) SNF ≤ 0.10The equipment should give accurate readings and repeatability if Fat and SNF as mentioned above.
- 9) Analysis speed required: Less than 50 seconds.
- 10) Sample Temperature: Raw milk should be able to be measured in a temp range of 5-35 deg. C or wider.
- 11) Sample Volume: Less than 10 ml.
- 12) Display: LCD, graphical display / colour TFT display.
- 13) Built-in Diagnostics: Equipment shall be able to perform all the required test to ensure accurate and error free operations.
- 14) System shall have the capability to transfer data by any suitable means from equipment through RS 232 or SD Card or Wi-Fi or facility of PC/laptop based software.
- 15) The instrument should be compatible with field operations i.e. dust proof, vermin proof and should withstand vibrations while mounted on vehicles.
- 16) Consumable and Accessories: Equipment should be supplied along with appropriate reagents, consumables, spares and accessories for routine operations for approximate analysis of 10000 samples during the warranty period. The requirement of these supplies for samples would be given to bidder on six monthly basis or on mutually agreeable dates.
- 17) Training: Basic training on operation / maintenance to be arranged by the bidder after installation of the equipment along with calibration development. The equipment should also be supplied with user manuals required for installation and training.
- 18) Warranty: Equipment shall be supplied with minimum a warranty of one year from the date of installation. Bidder should undertake on site minimum two preventive maintenance visits during the warranty period apart from the breakdown visits. Warranty would apply to all the accessories supplied by bidder.
- 19) Warranty extension: if equipment has been down for more than 30 days due to malfunctioning of the any part supplied by bidder or want of spares / consumable or workmanship, warranty would be extended.
- 20) Demonstration and Evaluation: Purchaser reserves the right to verify the performance of equipment at any stage of purchase process. The bidders are requested to arrange all the pre-requisite timely for successful demonstration and evaluation as

per tender / bidder specification.

- 21) Compliance: The reference / traceability of compliance information in the offer shall be clearly specified with supporting documentary evidences. The offer with incomplete / untraceable information may not be considered. Any type of unwarranted canvassing for selection of instrument may lead to rejection of the offer.
- 22) No offering of refurbished / assembled / demo modules: No part of the offered equipment shall be refurbished or used in demonstration purpose. Kindly submit undertaking.
- 23) The AMC charges for two years after the expiry of warranty period shall be quoted separately.
- 24) It is the responsibility of vendor to supply complete solution / unit for the analysis.
- 25) Vendor should be able to supply all the spares /consumable required for repair for at least 8 -10 years after installation.
- 26) The vendor should have minimum 50 installations in major dairies/ laboratories of the country, each year during the last three financial years and has demonstrated satisfactory performance of the equipment to the concerned stakeholders.
