For only the new product of Mahalaxmi Kohinoor Diamand the fabric will be a single piece pure Yellow Colour (pantone D6.605) as per IS-6192-1971 of HDPE Grade E 52009.
- 7) Mouth of Bag: The mouth of bag will be hamed. Mouth should be folded minimum 25 mm inside and stitched, so that the tapes do not fray.
- 8) Stitching: The bag should be bottom stitched only, double folded, double row reverse. The bottom of the bags should be folded inwards and stitched from inside only, outside by a minimum 20 mm. The bag should be bottom stitched with two rows of chain/lock stitches with a tape of 1200 denier. The first row of stitches will be uniform without any loose thread or knot.
- 9) Strength: The breaking strength of the sample bags will be as under.
 - a) Warp way (width wise) 90 kgf & below 90 kgf will be rejected or may be accepted with prorata basis as per tensile testing machine
 - b) Weft way (length wise) 90 kgf & below 90 kgf will be rejected or may be accepted with prorata basis as per tensile testing machine
 - c) Testing method as per IS 1969.
 - Seam breaking load, bottom seam 37 kgf and testing method as per IS 9030-1979.
 - e) Filler: 15 % (+/- 3 %) above 18% will be rejected as per muffle furnace method.
 - f) Elongation: 18 % to 23% below 18% and above 24% will be rejected as per tensile testing machine
