A) Technical specifications Biomass Briquettes

- 1) Moisture - 15%
- 2) Ash - 12%
- 3) Size - 70mm to 90 mm dia
- 4) Gross Calorific value (GCV) - 3800 (±100) Kcal/ kg

B) Special: Notes on Fuel-

- 1}The fuel should not contain any noxious, corrosive or toxic substances (i.e. PVC and other plastics, chlorine, wood protection products, heavy metals, etc.
- 2}Fuel to be free from any ;stones, metal pieces etc.
- 3}If using press mud as one of the raw material , it should be not more than 10%.
- 4} Chiken waste shall not be used as a raw material.

Sample procedure

- a)One briquette sample from each bag of any 30 nos. of briquette bags per vehicle will be collected.
 - b)One sample will be formed from above 30 nos of briquettes (Sr No. a))
 - c)This sample will be collected & sealed from authorised lab personal & will be tested for analysis.
- In case of supplied briquettes,we will not be responsible for any damages to the rejected briquettes if supplier fails to lift it within 10 days from getting information of rejection. Rejected material is to be lifted at suppliers own cost & risk and replacement is to be given within the same period.
