The reduction of pollution generated from the diesel generators.

System should be compliance to CPCB / MPCB / NCAP norms

Should be certified by one of the following recognized and approved agency by CPCB and as per guideline of system and procedure for emission compliance testing of retrofit emission control devices for DG sets

ARAI, Pune, ICAT Manesar, IIP Deharadun or VRDE Ahmednagar

It should promise reduction in harmful constituents of the diesel exhaust, i.e., Particulate Matter PM 2.5 and PM 10, Hydrocarbons & Carbon Monoxide with an efficiency of 70-90%, without causing any adverse impact on the Genset.

Along with the reduction of pollution, it also provides attenuation of flow induced noises.

Should consists such that particulate matter will be trapped and gets passively reduced along with gaseous components such as HC & CO.
